The announcement of an immediate freeze on US aid to fight HIV via PEPFAR has had immediate effects for beneficiary countries, by interrupting programs providing access to treatment, screening and prevention. Cuts in the development aid budgets of several European countries are likely to exacerbate this global crisis.
